Covid Vaccination Enhanced Service (ES)

- The email address <u>England.london-covid19voc@nhs.net</u> is a single point of contact for all Covid-19 vaccine queries and incidents in London. The email is monitored from 8am–8pm, seven days a week.
- Practices have been asked to provide an <u>Enhanced Service (ES)</u> for the delivery of the forthcoming Covid-19 vaccines.
- The full <u>ES and service specifications are available here</u>, local variation of the contract by commissioners is not permitted.
- Our guidance for practices on the Covid Vaccination Programme 2020/21 Service Specifications can be <u>viewed here</u>.
- Due to the nature of the vaccine and the scale of the project, although an ES (practice level contract), practices will need to work together on a PCN or locality basis to deliver this programme.
- To support the delivery of the individual and collective responsibilities of the collaborating practices as part of the Covid-19 Vaccination Programme (CVP), we have created guidance on <u>completing the</u> <u>Collaboration Agreement</u> and a template for the <u>Data Sharing Agreement</u>.
- An ES is a voluntary contract, practices have the choice as to whether they sign up to this. The LMC will support practices whatever decision they make.

Key points of consideration for practices/PCNs planning on delivering the Covid vaccine ES

- Designated sites needed to be identified and CCGs informed by 17 November. This was not a formal commitment to delivering the ES.
- Limited information is required: in addition to contact details for key people and the address/code of the site, an estimation of the number of vaccinations expected to be delivered per week (minimum 975) is required.
- Practices/PCNs/localities need to begin planning the logistics of delivering this programme which should be ready to commence at the beginning of December. However, currently it is predicted that the first vaccine stock will become available at the end of December.
- Practices should be entering into discussion at PCN and CCG level to determine what they believe is the most appropriate delivery model for them and their patients under the ES. Federations may also be able to support delivery.
- Information on the first, Pfizer BioNTech, vaccine including the cold chain requirements is rapidly changing. Initially there was concern that every site will need cold storage facilities, but the current information is that normal clinical refrigerator temperatures (2-8°c) will be sufficient.
- We will alert you to any significant updates regarding which vaccine will be available, cold chain requirements and preparation requirements as they become available. The <u>Standard Operating</u> <u>Procedure</u> for local vaccination services in community settings was updated on 14 January.

- To support this programme funding has been agreed:
 - o £12.58 per vaccination course.
 - A national sum of £150m for general practice (see the '<u>Outstanding</u> issues' section for a breakdown by London STP area).
 - A national sum of £120k per CCG to support GP recruitment.

Logistical challenges

The issues that will affect practices' ability to rapidly deliver this programme include vaccine supplies and delivery schedules, designated site requirements, workforce availability and public acceptance of the vaccine.

• Vaccine supplies:

This is being arranged nationally, possibly with the involvement of the army to support distribution. At present practices are being asked to commit to providing at least 975 vaccinations per week but we do not know if supplies will be sufficient to achieve this or if practices will be able to have sufficient stock to vaccinate many more.

• Designated site requirements:

Revised <u>guidance from the MHRA</u> issued on 9 December states that patients need to be observed for 15 minutes post immunisation. This is in addition to earlier information that people should not drive for 15 minutes post vaccination. This will have a significant impact on the capacity of the designated sites. We have produced a <u>spreadsheet enabling practices to calculate capacity</u> on the basis on needing an observation area following injection which allows for the 15 minute wait requirement post administration of the Pfizer BioNTech vaccine and two metres social distancing.

The British Society for Allergy and Clinical Immunology (BSACI) has advised that: individuals with a localised urticarial (itchy) skin reaction (without systemic symptoms) to the first dose of a Covid-19 vaccine should receive the second dose of vaccine with prolonged observation (30 minutes) in a setting with full resuscitation facilities (e.g. a hospital).

• New site approval

As the Covid Vaccination Programme develops, PCN groupings may wish to open additional sites or move sites as it becomes more apparent what the site requirements are to maximise delivery and the safe flow of patients through the vaccination process. Section 7 of the enhanced service deals with this and states that commissioners should have regard to PCN groupings preference and may invite PCN groupings to nominate additional sites as well as recognising that it may be necessary to amend a designated site.

• Workforce requirements:

The workforce we have available will significantly impact on the vaccination capacity. Surrey and Sussex LMCs have produced a <u>draft spreadsheet to help calculate the costs of delivering this</u> <u>service</u>, they have noted that this is an optimistic calculation as it makes a number of assumptions, does not take into consideration all costings and is based on the limited information about the ES.

Included in the Londonwide LMCs spreadsheet is a further tool we have produced – a calculator to determine your vaccine capacity based on the workforce available, which considers the financial envelop available to deliver this, alongside the cost of providing this service. Practices will need to consider the optimal model for the workforce they have available for delivery. We have discussed with some nursing colleagues how many vaccinators they feel could be supported safely. From these discussions a potential model is to form teams based on a GP/GPN supervising four HCPs who deliver the vaccine, with an administrator for every two vaccinators.

If people are required to be observed post vaccination this may require an additional person for every four vaccinators. As part of the planning phase practices should be discussing with their teams what is the optimal model to safely address their requirements.

• Public acceptance:

Across London, LMCs are in discussion with CCGs/ICS/STP about how to ensure that our ethnically diverse populations are provided with appropriate information that recognises cultural sensitivities. Through these routes, practices can be involved in local campaigns to ensure our patients receive the correct information to make an informed decision regarding the vaccine.

Nationally the Department of Health and Social Care (DHSC) is preparing information on the vaccine and vaccination programme for patients. Despite these developments significant numbers of patients will have individual queries regarding the vaccine. We believe that general practice will not be best placed to respond to, nor have the capacity to be able to respond to, these queries as it is unlikely that practices will have access to any information beyond that which is in the public domain. As such we believe a regional/national helpline will be required and are lobbying to get this service provided.

It is important that prior to the administration of the Covid-19 vaccination, the patient has *information they want or need to make a decision* to proceed with the vaccination. Outstanding issues

- The consent process needs to be confirmed:
 - Please see our paper on medicolegal considerations relating to the Covid-19 vaccines.
- The process for applying for a share of the additional £150m fund that have been released by NHS England to support general practice until the end of March has not yet been provided. This funding has been broken down by STP area:
 - o NWL £7.19m
 - NCL £4.11m
 - NEL £4.49m
 - o SEL £4.98m
 - 。 SWL £3.99m
- Londonwide LMC is entering into discussions with the STPs to ensure that as per the <u>national letter</u> 'CCGs should not introduce overly burdensome administrative processes for PCNs and practices to secure support' and that this funding resources is rapidly released to general practice to support the seven priority goals.
- In addition to this funding, the announcement that there will be £120k per STP/ICS to be utilised to support GP recruitment has not yet been discussed to understand how this will best support practices.

Income protection/reduced services

London CCGs have written to practices setting out what activities will be covered by income protection measures as part of their plans to allow practices to focus on core services, including vaccinations.

We will add further local examples from the other STP areas as they become available. Clinical prioritisation is essential to maintaining safe services; the <u>RCGP and BMA guidance on workload stratification and</u> <u>prioritisation</u> continues to provide a good framework for this

CCG actions

- 1. Support practices to focus on core services.
- 2. Suspend LESs/LCSs other than: vaccinations and Covid-19 related activity, for example reducing hospital admissions or supporting discharge. PMS KPIs are also suspended.
- 3. Review whether CCG management clinical staff could redeploy to support practice or PCN work.

National actions

- 1. Additional funding for PCN CD role to reimburse managing the Covid-19 vaccination response for Q4 (Jan-March 2021), equivalent to an increase from 0.25 WTE to 1 WTE for PCNs participating in the vaccination programme.
- 2. Minor Surgery DES income to be protected until March 2021 including the related additional service income in the global sum.
- 3. Quality Improvement domain in QOF to be protected in full at 74 points per practice until March 2021.
- 4. Eight prescribing indicators within QOF to be income protected on the same basis as the existing 310 points, using 2020/21 list size.
- 5. Appraisals can be declined, or GPs can use the revised 2020 model.
