LMC elections are now closed, the new committee will take up work on your behalf from 1 September 2018. You can find the details of the new committee by clicking here and further information will follow in the autumn. This year Dr Laurence Buckman will be retiring from the LMC after over twenty years of service and we would like to take this opportunity to thank him for all the hard work he has put in to support local GPs and practices over the years.

Barnet LMC continues to support GPs and practice teams to preserve a more sustainable general practice, working with the other NCL LMCs in areas of mutual benefit where issues are affecting a number of boroughs. Local LMC members meet regularly with the CCG, Federation, Public Health and the CEPN. The LMC is continuing to ensure that practices are getting the full benefit of resources identified including the Primary Care budget and the funding identified through the various funding streams of the General Practice Forward View (GPFV); for further information about GPFV resources click here.

Meetings have also taken place with the Royal Free to discuss issues relating to inappropriate requests made on general practice by the trusts as well as concerns regarding referrals. Similar meetings are planned across other trusts also. These will continue to be important as the electronic referral system is rolled out and the paper-based systems are switched off; trusts are working to a deadline of October 2018 for the completion of this project although it is likely that they will stop paper-based systems in August to allow a two month settling in period – if you experience any difficulties with e-RS please contact us so that we can follow this up.

The LMC is also feeding into the End of Life Working Group. Around 30 organisations have been invited to participate including representatives from primary and secondary care, the local authority, patient groups and the voluntary sector. The group is in the process of identifying achievable aims. Four key themes were identified at a CEPN Pan-Barnet event focusing on IT, communication, patient engagement and training.

2 PMS Contract Review

An NCL PMS Oversight Group was formed to ensure arrangements were consistent and fair across all five boroughs and that any arrangements agreed equalised arrangements for both PMS and GMS practices. Barnet CCG's commissioning intentions were assured on 20 February covering the next four years; they will focus on the management of long term conditions, improved access and working in collaboration with 111 and the emergency department. Throughout the negotiations the aim has been to ensure the CCG came up with an achievable plan with minimal numbers of KPIs to enable practices to be able to implement services with little additional effort. A joint CCG/ LMC meeting took place on 14 February with GMS and PMS practices to update practices on the plans. The majority of PMS practices have now signed their new contract with most GMS practices having signed up to the agreed commissioning intentions.

3 What is a CHIN?

CHIN stands for Care Closer to Home Integrated Network. A CHIN is a network of GP practices and local community services sharing the management of specific patient groups of 30,000-50,000 with locally identified needs for example frailty. A CHIN is not a physical hub providing one-stop care for all health needs.

What is happening across North Central London?

Across all five boroughs of North Central London practices are being encouraged to become a member of a CHIN. North London Partners who oversee the strategic direction of general practice across the whole sector see the CHIN model as a delivery mechanism that may enable GPs to work at scale and to allow a move of more services out of hospital to the community 'closer to home' within their local area. The LMC supports the ambition provided the much needed sufficient resources and funds move along into primary care.

How does this affect Barnet?

Three CHINs are currently active in Barnet with the plan to set up several more in this financial year. Recently MCLG meetings have been taking place to discuss CHINs, the current plans as well as the ideas to shape what CHINs could look like in Barnet. An LMC representative also attends Barnet Care Closer to Home Board which is an important forum as discussions and implementation of CHINs and supporting QIST continue.

4 Update on Locally Commissioned Services (LCSs)

The LMC continues to comment on plans for the locally commissioned services (LCSs) and to challenge areas of concern. The CCG is planning a review of LCSs and we will be meeting to ensure that practices' views are taken into consideration as part of this review. The CCG has plans to decommission the advanced care planning LCS as several areas are already covered by QoF; the other requirements of the LCS will be discontinued. Work is currently being

The CCG is planning to recommission a new anticoagulation LCS over the next six months. The LMC has raised concerns with the CCG regarding the additional pressures of the monitoring of patients on NOACs on practices; the need for appropriate training as well as ensuring that consideration is given to the clinical risk of transferring anticoagulated patients from secondary to primary care.

A letter has been sent to John Hooton, Chief Executive of Barnet Council with templates which have been developed to address issues arising around collaborative payment arrangements. There are two templates: one specifically for requests for information related to a child or adult at risk of a safeguarding concern and the other that relates to other types of collaborative payment.
