1.Delegated commissioning

Brent CCG wrote to practices on 24 February regarding the outcome of the member vote on delegated commissioning. Brent CCG has rescinded its application for delegated commissioning and will continue to operate as joint commissioners with NHSE. Brent LMC/LLMC will continue to engage with the CCG on this. Please look out for communications from your LMC.

2. PMS Review

The pause on the PMS contract review has been lifted and the process has restarted. The CCG will lead the process and be consulting with the LMC. We will keep you informed of the latest developments as they occur.

3. PCSE/Capita issues

Brent LMC is aware that significant concerns have been raised with the PCSE service provided by Capita. Although this is a national issue the LMC is keeping a close eye on the issues affecting practices locally and remind all practices to contact GP Support <u>gpsupport@lmc.org.uk</u> if they are facing significant financial loss because of these issues. Your LMC has received concerns about increases in service charges for CHP tenants. Practices should ensure that you have a clear understanding of what your service charges entail and why they may have changed. 6. LMC advice on the updated Brent EMIS ISA

You will know from the CCG that the Brent EMIS ISA has been amended to extend the sharing of the full medical record beyond networked/federated GP practices to sharing with numerous additional health and social service care providers giving direct care to the patient.

This extension of data sharing is a significant variation on the old EMIS ISA so GP colleagues **will need to sign up again to the new version** if you are in agreement with its terms and purpose.

Colleagues are reminded that your CCGs are <u>not</u> providing any indemnification to GPs or your staff to mitigate against legal action taken by a patient for alleged breach of confidentiality under these ISAs therefore: -

- Practices are strongly advised to take reasonable steps to inform patients that their full medical records will be shared with relevant health and social care providers for the purpose of giving direct patient care only
- To this end, practices are therefore strongly advised to ensure that a fair processing notice is displayed in a public place in the practice building and that patient leaflets and the practice website all contain copies of the notice so that patients will be aware that all data stored in their electronic medical records will be shared with relevant health and social care providers in accordance with data protection legislation and guidance for the purpose of direct care only.

<u>**Please note</u>** - The fair processing notice must mention that patients do have a right to decline the sharing of all or part of their electronically stored medical records. Practices are therefore advised: -</u>

- To have/put in place a process to enable patients to discuss any concerns and preferences.
- That reference to this process is clearly made in the fair processing notice.
