### 1. LMC Elections 2018 – Nomination open

Nomination packs were sent out on 30 April 2018 and the deadline for nominations is 5.00pm on Friday 1 June 2018.

This year every LMC seat is up for election.

We want any GP working within Brent to stand for election, regardless of their contractual status. We particularly welcome nominations from those GPs who are under-represented.

# 2. ERS - paper switch off

From 1 October eRS will be the only route for GP to Consultant-led first outpatient appointments, as part of the Standard Contract 2018/2019.

However, Trusts have staggered paper switch-off dates before October 2018 after which they will return all non-eRS referrals including those sent by email. (Please note this does not apply to diagnostics and community referrals.)

NHS England has issued <u>new guidance for managing referrals</u> including a list of FAQs which address issues such as two week wait referrals.

If you are having issues regarding training and support in the lead up to Trust switch off dates, or around availability of online appointments please contact your CCG IT lead in the first instance. If they are unable to resolve these in a timely manner, please make your <a href="LMC aware">LMC aware</a>.

#### 4. GDPR - latest news

The General Data Protection Regulation (GDPR) comes into force on 25 May 2018. We have produced a round-up of a significant amount of guidance to help you with integrating GDPR compliance into your practice systems.

- The Information Commissioner's Office (ICO) has just updated their website section on the right to be informed
- The ICO has produced an FAQs web page for <u>small health sector</u> <u>bodies</u>, a video on <u>data protection for small healthcare</u> organisations, and offers an advice service for small organisations.
- The BMA has a <u>dedicated GDPR web page</u> and NHS Digital has produced a <u>suite of GDPR resources</u>.
- The Information Governance Alliance (IGA) guidance document called 'the key points for GPs'

# 5. Responding to online comments about your practice

LLMC has published advice for practices on how to respond to online comments about their practice. Regarding negative comments, practices are advised to carefully consider how they wish to deal with them. A prompt response inviting the person who made the comment to contact the practice to discuss their views is a powerful reputation management tactic and a useful defence against an unfair comment. Although some practices prefer to ignore comments, this can backfire – it can look as if the practice doesn't listen or care about how the practice may be perceived. It is also a missed opportunity to point out all the good things you are doing. As it is free advertising, turn it on its head and use it. After all, if a comment was made in person in the surgery, they wouldn't be ignored.
