3. Practice concerns - and your LMC

Ealing LMC are following up practice concerns in a number of areas including:

- Community cardiology work assignment seeking to ensure that work is not passed on to GPs that should be handled by community cardiology nurses
- Incorrectly addressed mail issue of hospital trusts sending emails to GPs personal email addresses rather than to the practice email address resulting in some communications not being followed up when a GP is on leave. The CCG have agreed to reissue trusts with an up-to-date list of practice email addresses
- X-ray referrals by locums the LMC has asked the CCG to look at the new over-stringent rules that prevent locum GPs not registered with the practice from directly referring patients for x-rays
- Difficulty in practices accessing information about child patients with a child protection plan

If you have examples in any of these areas please let us know so we have a fuller understanding of the issue we are raising.

Patients and Out of Hours dental issues

The GMS contract does not include dental services, though a GP has a duty to determine whether a patient's problem is medical or dental. For Out of Hours services, Care UK should NOT charge practices for costs of out of hours dental consultations; these should be covered by the dental contract. Any instances of a particular dentist or group of dentists failing to provide a service to patients should be taken up with the local dentist association.

Pathology tests – with no note!

The LMC has received one or two reports from practices receiving pathology tests which have no accompanying clinical note. We are following this up with the CCG. If this has happened at your own practice let us know (removing patient identifiable information from the example) – the CCG need examples in order to follow up the issue.
