### 1. NHS Health Checks (Harrow)

Harrow and Barnet Joint Public Health Commissioner notified practices, by letter dated 8 December 2015, that NHS Health Checks activity in Harrow would need to cease until further notice, as a result of in-year cuts to the Public Health Grant. It has been brought to the commissioner's attention that a number of practices had already sent out invitations to their patients prior to receiving this letter and are concerned that they may incur costs that will not be re-reimbursed.

If your practice can evidence that you sent out invitations for NHS Health Checks prior to the 8 December 2015 and have undertaken before the end of March 2016, Public Health will pay for all checks that qualify. Please contact Denise Mortimer at PublicHealth@harrow.gov.uk for further details.

#### 2. Personal Medical Services (PMS) review

Discussions are ongoing regarding the PMS review and the London offer. PMS practices should have received information from NHSE on their practice finance including capitated figures. Practices are advised to carefully check the financial information sent to them from NHSE for errors.

## 4. 2016/17 Contract changes

NHS Employers and the British Medical Association's General Practitioners Committee (GPC) announced changes to the GMS contract in England for 2016/17 on 19 February 2016.

The GPC has negotiated an investment of £220 million into the GP Contract for 2016/17, representing an approximately 3.2% overall uplift, the largest for some years. This includes an absolute 1% increase in contract value, but, additionally, contributions towards the rising costs of medical indemnity, national insurance and superannuation, CQC fees, and utility and other costs. The 1% uplift will be subject to the current 5.34% OOHS deduction, but the monies supporting expenses reimbursements and the retired Dementia DES will not.

### 5. Primary Care Apprenticeships

Londonwide LMCs and Health Education NWL are currently working with Training Providers who can deliver apprenticeships in the following fields:

- Business and Administration
- Management
- Customer Service
- Clinical Healthcare Support Worker

A programme will normally take between 12 – 18 months and consists of on the job training, skills assessments and off the job learning. As the employer practices would be required to make a commitment of a minimum salary, an in-house mentor and access to training.

Recognising the diversity of the health workforce, Health Education England North West London have made funding available to support all of the training costs for either new or existing staff, regardless of age - normally you would have to make a contribution to the training costs for those over 18.

Unfortunately this money is only available during the current financial year, so to take advantage of it you will need to commit to taking an apprentice, or placing a suitable existing member of staff on an apprenticeship programme, before the end of March.
