Welcome to the first News Update for 2019 and with the New Year comes a New Plan!

1. NHSE Ten-Year Plan

NHSE have launched their Ten-Year Plan

The devil will be in the detail but the £20 billion promised is not new money and won't make up for the shortfall to the NHS caused by ten years of austerity.

The plan mentions Integrated Care Systems and provides very short time lines for our local NHS teams to put plans in place, with the deadline for the plan for the first year being the end of March.

Practices should beware of anything that entices them to give up their GMS contracts. GMS contracts while not perfect, give practices the security of knowing that their contract cannot be put out for tender. APMS or any other sort of contract are short term and always at risk of being awarded to a private health provider.

2. Shared Care Guidelines for adult ADHD

The LMC have recently become aware of Shared Care Guidelines for adult ADHD. We are afraid that we cannot support the guidelines which make GPs responsible for prescribing for adults. The LMC feel that this is a specialist area and out with the expertise of General Practice.

3. Minor Ailments Scheme

Discussions are ongoing re the next iteration of the Minor Ailments Scheme. The national scheme comes to an end at the end of March. The scheme allowed patients who are entitled to free prescriptions to access simple medication free at the pharmacy without needing to come to the GP for a prescription. The concern is that the loss of this scheme will increase GP workload as people come to us for a prescription. The CCG are working with Hackney CCG to provide a local solution.

4. Phlebotomy

The Phlebotomy contract is proposed to be changed from a fee per item to a block contract. There is apparently a large overspend on the contract as it currently stands. The CCG, by introducing the block contract and capping the budget, have been able to avoid the contract going out to procurement, so keeping the activity in General Practice, but there are obviously concerns as to what will happen if the cap is exceeded and what this will mean for practice staff and workload, especially as work is transferring from hospital to the community with the new RAS service and the drive to reduce out-patient attendance. The LMC have written to Henry Black, Chief Finance Officer at East London and Health Care Partnership to express our concerns.

5. NIS round

The annual negotiations between the CCG/GPCG and LMC regarding changes to the NISs is about the begin. The LMC have fed back concerns that many of you have already alerted us to such as the complexities of the Prescribing NIS and fears around the quarterly rolling targets. Please let us know if you want us to feed anything else in.

6. NHS Property Services

Issues with NHSPS continue. For those of you in NHSPS premises the advice is the same as it has always been. This is a national problem and there are practices all over England who are withholding their service charge payments and have not signed a lease. Please do not be coerced into signing a lease that you are not 100% happy with. Ensure that all service charges are fully itemised and relate to your practice and not to another occupant of the building if you share premises. Keep in contact with NHSPS and say that you are happy to comply when your reasonable requests have been met. Please keep a sum of money aside to pay outstanding charges when they are finally agreed.
