Despite all this, together we have managed to keep the GP boat afloat – we are grateful for all your contributions. Please remember the LMC is your LMC.

### 1. Over the Counter Medication

We are aware that GPs are coming under pressure not to prescribe medication that is available over the counter. Whilst the LMC understand that the NHS budget is under considerable pressure due to the unprecedented financial squeeze imposed since 2010, we do not believe that it is the job of the GP to ration care. Patients may rely on regular medication that is available over the counter and be unable to afford it. The BMA is clear that:

#### Prescribers should:

- Continue to make the care of the patient first concern
- Advise patients if that treatment for their condition is available over the counter
- Provide an FP10 if, in the opinion of the GP, not to do so may put the patient at risk of not having necessary treatment.

#### 5. Transfer of Services from ACE in Clacton to PSCE

## **Contacting PCSE for your primary care support services**

As part of Primary Care Support England's (PCSE) commitment to providing national, consistent services for primary care, we are planning to transfer services currently delivered by ACE in Clacton to PCSE, from March 2019.

ACE currently provide support for GP Payments and Pensions for the following areas in London:

Redbridge & Waltham Forrest
East London & City

The plan is to move the GP Pensions service to our Blackburn office from 1 March. The GP Payments service for practices in your area will also move to Blackburn and transfer on 1<sup>st</sup> March.

The way the work is processed will not change and there will not be any interruption to the service our customers receive. However, we are writing to remind you that **all** contact with the ACE office should be directed to PCSE's Customer Support Centre and via the online forms on the PCSE website.

We will also be writing to all affected GP Practices to advise them of this update.

All contact with PCSE for queries or requests relating to <u>GP Payments</u>, <u>GP Pensions</u> or <u>Cervical Screening</u> should be via the online forms that are available on the <u>'Contact Us'</u> page of the PCSE website.

The online form also has a section specifically for LMCs.

- Visit the 'Contact us' page
- Select either 'GP Payments' or 'GP Pensions' as the enquiry type
- Enter your details and select 'Yes' when you are asked if you represent an LMC.

Please include as much information as possible to allow PCSE to easily identify, investigate and resolve the enquiry as quickly as possible.

You can also contact PCSE's Customer Support Centre (CSC) on **0333 014 2884.** The opening hours for the CSC are 08.00-17.00, Monday-Friday.

Online form and telephone contacts are each allocated a case reference number, so we can track and keep you updated on the progress of your query and you can follow-up if required.

As these contact arrangements have already been in place for a year, since February 2018, practices should not need to do anything differently.
