#### 1. Message from the LMC

The LMC continues to work with the CCG, Public Health and the Confederation meeting regularly to discuss and comment on current issues.

We have also secured a place on the Health and Social Care Transformation Board. This board oversees all the work done as part of the integration of health and social care in City and Hackney. By having a place on the board, the LMC can ensure that GPs views and interests are heard when decisions are made.

We have met with the Homerton to try and ensure that they adhere to the changes in the Standard NHS contract that came into being in April, see Item 5 of the newsletter for more detail, and we will be meeting with the local pharmaceutical committee to explore ways that we can work together and support each other.

As practices are aware, the Sexual Health and Family Planning services are being reconfigured and re-commissioned by Public Health. This will have a big impact on practices, we will endeavour to influence the proposed changes to enable us to continue to offer high quality care to all our patients.

#### 3. Update on the PMS Review

As part of the London programme of PMS reviews, C&H LMC continue to engage with the CCG and local practices, regarding plans for the redistribution of PMS Premium funding.

Londonwide LMCs are in the process of jointly assuring the C&H Commissioning Intentions and also financial and transitional support plans, based on the CCG's plan to utilise PMS Premium funding for the creation of an extended FHV register/services. The ask from practices for this year is to create a register, with all practices are expected to have a register. It is intended that the whole of the premium released this year is ring fenced to pay practices for creation of the register.

Detailed plans are currently being finalised for formal consultation through C&H LMC; these will then be subject to a joint assurance process involving Londonwide LMCs and NHS England London – further details will be shared with practices.

#### 4. East London Health and Care Partnership

Dr Jackie Applebee, Chair of Tower Hamlets LMC, attended the launch event of the East London Health and Care Partnership on Monday 3 July. She has outlined her views on the event below:

I attended the launch of the East London Health Care Partnership (formally the NEL STP but there has been a rebrand!) on 3 July. This was held in Stratford Town Hall and was opened by the Mayor of Newham, Sir Robin Wales. There were at least 200 people in attendance from across the NHS and Local Government. We were introduced to the programme leads for each area of the STP and Anne Rainsbury, Regional Director for London, was there from NHS England.

Whilst I understand that the STP is yet another top down "disorganisation" from the Government and have the greatest respect for those trying to implement the, in my opinion, unimplementable, I was very concerned with the messages that I took home from the meeting. This may be deemed unfair but it seemed as if we were being told that if patients would only stop smoking, lose weight and stop abusing the NHS that all would be well and it would be possible to save the eye watering sums that are being asked of us (the financial gap in NEL is over £500m).

Prof Sir Michael Marmot's work shows clearly that the most deprived people have the least control over their lives and find it extremely hard to act on health messages even if they hear and understand them. Parts of NEL are amongst the most deprived in the country, we are also due to have a population rise of over 300,000 in the next few years. To add to this, the plan is still to go ahead with the closure of A&E at King George Hospital in Ilford, with the obvious knock on effects to the other already teetering hospitals in NEL.

The financial demands of the STP/ELHCP are unachievable without huge cuts to services. We should be honest about this. You can visit the ELCHP website <u>here</u>

### 5. North East London Integrated Urgent Care Service (NEL IUC)

A procurement process is underway across 7 CCGs in North East London to find a new single NEL Integrated Urgent Care Service (111). The service is envisaged to have a 24/7 Clinical Assessment Service, with a range of clinicians supporting the telephone triage system, and to have the facility for direct booking in to primary care.

The CCG is keen to work with practices explore how direct booking could work; look out for updates and requests for practice engagement from Anna Hanbury at City and Hackney CCG.

#### 6. NHS Standard Hospital Contract

The LMC met with Dylan Jones from the Homerton to discuss blanket DNA policies and the inappropriate transfer for work in to practices. It was not felt by the hospital that there is a problem with the transfer of work to primary care, and any issues should be taken up by the CCG as commissioners.

The new hospital contract came in to force in April. The BMA has produced guidance and templates to provide practices and LMCs with resources to hold both CCGs and hospital trusts to account in implementing these contractual changes.

#### 7. Public Health Updates

#### i) Hepatitis A Outbreak

An outbreak of Hepatitis A has been ongoing across England since July 2016, with the majority of cases reported in London. Public Health England has produced new guidance, available here. Guidance includes:

- Changes to NaTHNaC recommendations for Hepatitis A Vaccine for other countries
- Alternative vaccine options of Hepatitis A vaccines to mitigate effects of supply constraints

GUM clinics have received advice via a letter from the British Association for Sexual Health and HIV (BASHH) and BHIVA.

#### ii) Sexual Health Services

New sexual health contracts have now been awarded. The terrestrial service has been awarded to the Homerton and the e-service to Chelwest. Public Health will communication directly to practices with more information about these changes.

#### GMS 2017/18 Contract Changes

#### **Indemnity Fees:**

Additional funding will be paid directly to practices on a per patient basis. This is intended to cover the increase in indemnity costs for all GPs working in the practice, including salaried GPs. GP partners should ensure that the appropriate amount of funding reaches their salaried GP colleagues.

Locum GPs will need to ensure their invoices/agreements with practices are uplifted appropriately to take this in to account.

#### CQC Fees:

Part of the 2017/18 contract changes include full reimbursement of CQC registration fees.

The process for claiming fees back has now been published; Londonwide LMCs have produced a short piece of guidance available on the website <u>here</u>.

#### **Fragility Reviews:**

From 1 July practices need to identify patients over 65 living with frailty (using a tool such as eFI).

Those identified as moderately frail require this to be recorded in their notes.

Those identified as severely frail will need:

- an annual medication review
- any falls in the last 12months recorded
- turning on the enriched SCR discussed and the outcome recorded

There are no returns associated with this new requirement, and no thresholds to meet in terms of the data extracted.

#### iii) BCG Vaccine

Global supply of BCG vaccine is no longer constrained and Public Health England has concluded that there is currently sufficient stock of Intervax BCG vaccine to extend the offer of vaccination to all eligible groups.

There is no catch-up campaign for those who were not immunised during the vaccine shortage.

#### 8. Data Provision Notice – GP Workload Information Collection

Practices will have received a notification from NHS Digital regarding the GP Workload Information Collection. The data is going to be used to look at appointment numbers, types, skill mix and availability. NHS England has directed NHS digital under section 254 of the Health and Social Care Act so it is a requirement to comply with the extraction. No patient identifiable information will be extracted and so no consent is required from patients.

#### 9. NHS Property Services

The LMC often receives queries regarding service charges and lease issues. Latest Londonwide LMCs guidance, covering service charges and lease negotiations, can be found <u>here</u>.

#### 10. Resources to help practices manage workload

#### i) GP State of Emergency

To help you through the GP state of emergency visit the <u>GPSOE</u> site.

There you will find waiting room posters, template letters and supporting guidance on a wide range of common topics such as requests for verification of absence letters from schools, housing applications, DWP appeals and much more.

#### iii) Patient Online

The toolkit to help GP practices promote online services to patients helps practices to promote online services, including ordering repeat prescriptions, booking appointments and viewing medical records. Any queries can be sent to England Patient

#### Influenza and Pneumococcal Vaccinations and Immunisations:

The influenza and pneumococcal vaccination DES contains an explicit requirement that practices operate a call and recall system for at-risk patients. The childhood immunisations and imms and vacs additional services regulations do not contain such an explicit requirement though this is clearly highly advisable as there is an obligation therein to offer vaccination whenever appropriate and to take steps to maximise uptake.

#### **National Diabetes Audit**

Whilst most practices are already taking part in this annual audit, please remember that from July 2017 all practices will be contractually required to allow collection of data relating to the NDA.

# Employers' requests to see appraisal summaries

It has come to the attention of Londonwide LMCs that some prospective employers have been asking candidates to share their appraisal summary. The LLMC view supported by colleagues on the GPC, is that this is unacceptable practice.

GP appraisal documentation is highly privileged information with restricted access for specific purposes only relating to the Medical Register, Licensing and Performers' List requirements. It is reasonable that the potential employer requests evidence of regular appraisal and date of revalidation. This could be a screen shot of the appraisal page on Clarity showing appraisal dates.
